- Synthesize technical information for use in communications material for leadership and stakeholders about key natural resource management issues.

# Qualifications Conditions of Employment

This position is located within the Department of Commerce (DOC), National Oceanic and Atmospheric Administration (NOAA), National Marine Fisheries Service (NMFS), West Coast Region (WCR) with two vacancies located in Seattle, WA; Lacey, WA; or Portland, OR.

This position will be filled under the DOC Alternative Personnel Systems (CAPS). This system replaces the Federal GS pay plan and structure. Under CAPS, positions are classified by career, pay plan, and pay band.

The ZP-4is equivalent to the GS-13/14.
